

NOTIFICATION

WHEREAS last elections for the Boards of Directors in 4 Nos. Co-Operative Societies under Uttar Dinajpur Range were held having Regn. Nos., Regn. Dts and Registered Office Addresses as per the Annexure of this Notification;

AND WHEREAS the tenures of the elected Boards of Directors of the said societies have expired in terms of section 36(a) of the West Bengal Cooperative Societies Act, 2006;

AND WHEREAS elections for reconstitution of the fresh Boards of Directors of the said societies are yet to be held;

AND WHEREAS it has been felt necessary for appointment of Special Officers in the said co-operative societies with a view to facilitating the constitution of elected Board of Directors therein and to manage all the affairs of the said Co-operative Societies;

AND WHEREAS the Registrar of Co-operative Societies, West Bengal has proposed the names of officers as per the Annexure of this notification to be appointed as Special Officers for the said Co-operative societies.

NOW THEREFORE, the Governor in exercise of powers conferred under Section 36 of the West Bengal Cooperative Societies Act, 2006, as amended thereto, is pleased to appoint the officers as per the Annexure of this Notification as Special Officers of the Said Co-Operative societies in addition to their normal duties for a period of six months in each case in the interest of the said Co-operative societies in particular and the Co-operative movement in the State in general with effect from the date of the issuance of this Notification or until further order whichever is earlier with a direction that they will take all necessary steps under the supervision, direction and control of the Cooperative Election Commission, West Bengal for constitution of elected management of the said societies during their tenure, exercise all powers and perform all the duties of the Boards of Directors of the said co-operative societies subject to control and direction of the Registrar of Cooperative Societies, West Bengal in accordance with the provision of the West Bengal Cooperative Societies Act, 2006 and to make over the charges to the newly elected Boards of the said societies as soon as those are constituted.
